WHEREAS, WAC 136-16 requires the legislative authority of each county prepare and adopt an Annual Construction Program (ACP) that includes proposed road and bridge construction work for the ensuing calendar year; and


WHEREAS, on the 22nd day of October 2015, the 2016-2021 Six Year TIP and 2016 ACP were submitted to the office of the Board of County Commissioners (BOCC) of Lewis County, Washington; and

WHEREAS, the 2016-2021 Six Year TIP and 2016 ACP reports, and all related materials have been reviewed by the BOCC and found appropriate for further proceedings.






