RESOLUTION NO. 15- 359

WHEREAS, the Board of County Commissioners of Lewis County has met and considered its budget for the calendar year 2016; and,

WHEREAS, the Board of County Commissioners of Lewis County after hearing and after duly considering all relevant evidence and testimony presented, determined that Lewis County's regular levy budget would be \$12,200,000; and,

WHEREAS, the Board of County Commissioners of Lewis County Road District after hearing and duly considering all relevant evidence and testimony presented, determined that Lewis County Road District levy budget would be \$11,500,000; and,

WHEREAS, The Board of County Commissioners have determined there is a need for a .251% increase in both the General and the Road levy rates;

NOW, THEREFORE BE IT RESOLVED the Lewis County Board of County Commissioners hereby sets the budget for both the General and Road levies and approves a regular County levy increase of \$29,767.11 or .251% over the previous year's levy amount and approves a Road levy increase of \$27,900.60 or .251% over the previous year's levy amount, in addition to the increase resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property.
