WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, the Koontz Road overpass across Interstate 5 between Mile Post 1.95 and Mile Post 2.0 received damage as a result of an accident on Interstate 5; and


WHEREAS, it will be necessary to close Koontz Road between North Military Road and Coulson Road to all through traffic until the overpass has been repaired and deemed safe for travel; and

WHEREAS, Koontz Road will remain open for local access from either end up to, but not beyond, the points of closure between Mile Post 1.95 and Mile Post 2.0, and other county roads are available for detour.

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW 47.48.010 and .020, beginning 12:00 a.m., April 11, 2016, and ending 6:00 p.m., December 31, 2017, Koontz Road between North Military Road and Coulson Road, in Section 36, Township 13 North, Range 2 West, W.M., and Section 1, Township 12 North, Range 2 West, W.M., shall be closed to all through traffic.





**NOTICE IS HEREBY GIVEN** that the Board of County Commissioners, Lewis County, Washington, approved the temporary closure of Koontz Road to all through traffic due to damages to the Koontz Road overpass across Interstate 5 located between Mile Post 1.95 and Mile Post 2.0 as a result of an accident on Interstate 5. Koontz Road will be closed to all through traffic between North Military Road and Coulson Road. Koontz Road will remain open for local access from either end up to, but not beyond, the points of closure and other roads are available for detour. Pursuant to RCW 47.48.010 and .020, beginning 12:00 a.m. April 11, 2016 and ending at 6:00 P.M. December 31, 2017, Koontz Road between North Military Road and Coulson Road, in Section 36, Township 13 North, Range 2 West, W.M., and Section 1, Township 12 North, Range 2 West, W.M., shall be closed to all through traffic.
