This annual report is prepared to assist you, as property owner, taxpayer, and citizen, in understanding the functions of the Lewis County Assessor's Office. We take pride in the services we provide to you and welcome your comments on how we may improve our processes.

Our website, www.lewiscountywa.gov, houses valuable resources such as PARCELS and the most current information about property assessments, taxes, and mapping information. You will find it user friendly and informational. If you have questions about the site, please contact my office during normal business hours, or use the Help (“?”) screen on PARCELS.

Initiative 747 limits taxing districts to a 1% annual increase over last year's lawful levy amount. Overall tax collection in 2015 was \$78,002,439.73 and for the 2016 tax year, the amount to be collected is \$79,459,827.56 resulting in an approximate 1.02% increase in taxes countywide from the previous year. Voted levies passed by each district are not included in the 1% limitation.

The Lewis County Assessor's primary function is to determine the value of all taxable real and personal property. All properties must be assessed at 100% of true and fair market value for tax purposes with variations, as required by law. Lewis County has approximately 59,709 parcels of real property, which must be inspected and appraised no less than every six years. Lewis County also assesses 3,502 Personal Property and State Assessed Utility parcels. The total number of real and personal property parcels assessed is 63,211, an ever evolving number due to property merges and splits.

There are approximately 60 taxing districts which submit budgets annually to the Assessor to determine the amount of tax to be collected. In 2016, the total taxable value is \$7,057,914,504, a 1% increase in the county's aggregate taxable value from 2015. In 2016, the new construction value countywide was \$58,963,744, a 14.7% increase from the previous year.

Prior to 2012, Lewis County was a cyclical county where all real property was revalued once every four years. The 2009 Legislature passed a law requiring all counties in the state to annually value taxable property no later than the 2014 tax year. This allows counties to respond to current sales trends in each area. If the market decreases or increases, counties will be able to respond to that decrease or increase the next year. Lewis County converted to an annual revaluation cycle for the 2012 tax year. All real property is now physically inspected once every six years according to the revaluation maps on lewiscountywa.gov under PublicWorks/ GIS Map Library/ Assessor Parcel Maps/ All Revaluation Areas.

In 2015, we physically inspected and reappraised the Eatonville, Morton, and White Pass School Districts, decreasing values by 1% overall. The other 5/6 of the county was statistically updated.

The Lewis County Assessor's Office provides training classes upon request for any group that is interested. Several training classes were held with fire districts and community clubs in 2015. Please contact my office to set up an appointment to discuss and schedule possible training opportunities.

If there are enhancements you would like to see added to our website or PARCELS, please contact me and I would be happy to discuss them with you. We are always open to suggestions on how we can make your visit to my office or your electronic experience with our online resources easier and more efficient for you.

ASSESSMENT AND TAX INFORMATION

The function of the County Assessor is not the levying of taxes, but the appraisal of property for establishing valuation upon which city, county, state school, local school, library, port, fire, hospital, cemetery, and county road taxing districts may levy taxes.

REAL PROPERTY assessed value is 100% of true and fair market value at the time of appraisal. The Assessor uses computer-assisted appraisal methods which apply professionally established processes of estimating value. The Assessor is required to maintain an active and systematic program of real property revaluation on a continuous basis; every parcel in the county must be physically inspected and reappraised at least once every six years. Lewis County is an annual county of revaluation. This program allows the Assessor to respond to current market conditions with a more equitable and cost effective method of assessment.

TAXABLE PERSONAL PROPERTY includes agricultural machinery and equipment, manufacturer's, contractor's, and logging machinery and equipment, office machinery and equipment, and supplies and materials which are not held for sale or do not become an ingredient or component of an article being produced for sale. Furniture and fixtures in commercial use, leased equipment, certain leasehold improvements, franchises and easements of intra-county public utilities, leased owned improvements on public land, and commercial vessels not subject to excise tax are also assessed and taxed as personal property.

Most personal property assessments are based on information provided by the taxpayer on personal property affidavit forms furnished by the Assessor. The Assessor uses this information to determine value, taking into consideration the age, cost and type of property. When the affidavit is processed and the property is valued and entered on the assessment roll, a Personal Property Valuation Notice is mailed to the taxpayer.

TAXPAYER'S RIGHT OF APPEAL: If, after receiving a Notice of Change of Value on your property, you think that the new value does not represent market value, you should consult the Assessor's Office. The appraisal of your property will be reviewed, and if you still do not think the value represents market value, you may petition for a hearing before the Lewis County Board of Equalization (BOE). The BOE convenes in July of each year. When you receive your notice, if you chose to file an appeal, you have you must do by the date listed under "IMPORTANT DATE" on the front of your notice. Please note: this date changes every time you receive a new notice. You must appeal each and every year individually.

TAXES: Assessments are made as of 12:00 noon, January 1st, and taxes are due and payable as soon as they are established. First half taxes must be paid by April 30th or the entire tax becomes delinquent. Second half taxes become delinquent if not paid by October 31st.

LEVIES: The aggregate of all regular tax levies (excluding state schools) shall not exceed the limit of \$5.90 per thousand dollars of assessed value without voter approval.

The statutory levy for taxes payable in any year may be exceeded only by a vote of the electors. The ballot must state the dollar amount sought, and the estimated levy to produce that amount.

Taxes are not the same throughout the county due to three factors:

1. The various combinations of taxing districts (cities, fire districts, etc.) found in different areas of the county
2. The size of the budget of each taxing district (regular levies)
3. Special levies and bond issues approved by the voters (excess levies)

County departments submit their budgets to the County Commissioners. Based upon the budgets, the County Commissioners certify the amount of the taxes to be levied to the Assessor.

The Assessor determines levy rates by dividing the amount to be levied by the assessed value of the taxing district. Levy rates are expressed in dollars per \$1,000 assessed value.

SENIOR EXEMPTIONS: An exemption is available for senior citizens and disabled persons. If you own a residence, are 61 years of age or older, or are 100% disabled, and have an income less than \$40,000, you may be eligible for a property tax exemption. State law also allows recipients of the exemption to defer any remaining taxes or special assessments up to 80 percent of their equity in the residence. The deferred taxes become a lien against the residence which is satisfied when the property is sold. You may apply at the Lewis County Assessor's Office.

HOME IMPROVEMENT EXEMPTION: Physical improvement to a detached single family dwelling may be exempt from taxation for the three assessment years subsequent to the completion of the improvement, up to 30% of the value of the original structure; the home improvement exemption may be claimed only once in a five year period. Normal maintenance work does not qualify for this exemption. Notice must be filed prior to completion of the improvement being made on forms furnished by the Assessor.

DESTROYED PROPERTY: If, on or before December 31 in any calendar year, any real or personal property placed upon the assessment roll in that year is destroyed in whole or in part, the value of such property shall be re-appraised and reduced considering the date and destruction value as determined in provisions of law. Claim for reduction of assessment shall be filed with the County Assessor as soon as possible and within three years after the date of the destruction or loss of value.

CURRENT USE VALUATION: The Open Space Act provides for Current Use assessment of Farm and Agricultural land and other open space land. Applications for classification are made to the Assessor for all Current Use programs.

Once land is classified, taxes are based on the Current Use value of the land rather than its highest and best use. The Assessor must maintain the Current Use value for as long as the property remains classified. At the same time, a record of the market value of the property is retained. The difference between the Current Use value and the market value becomes the basis for computing the additional taxes, penalties, and interest that may become payable upon a change of use or removal from classification.

FOREST LAND: Forest land is subject to property tax under RCW 84.33.010. Land that has been designated under the law is assessed in accordance with valuation schedules developed by the Department of Revenue. The Assessor must determine which lands qualify and then assess the land according to forest land rates certified by the Department of Revenue.


To qualify as designated forest land, a parcel must have at least 5 acres of eligible land and must be devoted primarily to, and used for, growing and harvesting timber. You may have multiple parcels of eligible land that total up to the 5 acres but they must be contiguous. Designated forest land may be subject to a compensating tax if the use of the land is changed or upon an owner's request to remove the classification or designation.

OPEN SPACE TIMBER: Is no longer an available option in Lewis County. In 2014, the Lewis County Board of County Commissioners adopted a resolution that allows us to value all qualified timber land in a program as Forest Land. The requirements for Forest Land are in the paragraphs above.

HISTORIC PROPERTY: Historic property exemption is property which is listed in a local register of historic places created by comprehensive ordinance, certified by the Secretary of the Interior or listed in the national register of historic places. You may receive an exemption on a portion of your rehabilitation of the property. For more information see www.dahp.wa.gov.

WATER QUALITY EXEMPTION: Taxpayers may apply for a property tax exemption for improvements to property devoted to fish and wildlife habitat restoration and protection and to water quality and quantity improvements. To qualify, the improvements must be in accordance with a local conservation district's written plan for best management practices. You must apply at the Lewis County Conservation District.

TAX DOLLAR DISTRIBUTION



The disbursement of your tax dollar is shown above. For every dollar of property taxes paid, the taxing district received the amount shown in cents, i.e. \$.2032 is collected by the County Treasurer, remitted to the State and redistributed to the school districts for school support. Other moneys collected are distributed locally to the remaining taxing districts, with the exception of Timberland Library, a joint county taxing district.


