RUSH ROAD AND WIDENING OF A }
PORTION OF MAURIN ROAD }

RESOLUTION NO. 09-355

WHEREAS, on the 14th day of October, 2009, the Engineer's Report on the matter of accepting the establishment of an Extension of Rush Road and widening of a portion of Maurin Road was filed in the Office of the County Commissioners of Lewis County, Washington, more particularly, said establishment to be a County road at no less than sixty (60) feet in width, in the Southeast Quarter (SE¼) of Section 10, in the Southwest Quarter (SW¼) of Section 11, in the Northwest Quarter (NW¼) of Section 14, and in the Northeast Quarter (NE¼) of Section 15; Township 13 North, Range 2 West, W.M., lying along and on each side of the following described centerlines of Rush Road Extension and Maurin Road:

Rush Road Extension: Beginning at the East Quarter Corner of said Section 10; thence South 02°11'31" West, 30.16 feet, to a point on centerline designated Engineer's Station 0+00, the TRUE POINT OF BEGINNING, thence South 02°11'31" West, 3,525 feet to Engineer's Station 35+25, and there to terminate.

Maurin Road: Beginning at the East Quarter Corner of said Section 10; thence South 02°11'31" West, 30.16 feet, and South 88°21'55" West, 1,257.63 feet to a point on centerline designated Engineer's Station 37+50, the TRUE POINT OF BEGINNING; thence North 88°21'55" East, 1,257.63 feet to Engineer's Station 50+07.63, and there to terminate.

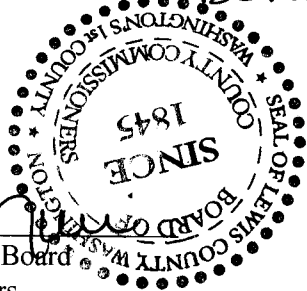
WHEREAS, said report and all related materials have been reviewed by the Board and found appropriate for further proceedings;
