





**NOTICE IS HEREBY GIVEN** that the **LEWIS COUNTY, Washington Board of County Commissioners** will hold a **public hearing on November 28, 2011**, to receive public testimony concerning adoption of Ordinance No. 1227, amending Title 17, Lewis County Code to add a new section 17.300 specific to code compliance. The hearing is scheduled to commence on or after 10:00 AM, November 28, 2011, in the Commissioners' Meeting Room in the Lewis County Courthouse, second floor, at 351 NW North St., Chehalis, WA. Anyone wishing to testify concerning the proposed ordinance should attend and be heard.

The following summarizes the proposed Ordinance No. 1227:

Adoption of Ordinance 1227 will add a new Chapter 17.300 to Lewis County Code, implementing new processes and penalties for violation of county code. The new code provisions address general enforcement powers associated with public health, public roads, building and construction, subdivision of land, and land use and development. Penalties for non-compliance up to \$1,000 are authorized with infractions being a misdemeanor or gross misdemeanor. New processes and penalties are in addition to those code compliance processes and penalties already contained within existing county code provisions.
