WHEREAS, purchases or leases may thereafter be entered into by securing telephonic or written quotations from at least three different vendors whenever possible to assure that a competitive price is established and for awarding the contracts for such leases or purchase to the lowest responsible bidder as defined in RCW 43.19.1911. Authority for such leases or purchases is effective for the period of one year from each publication of notice and solicitation of vendors. Vendors responding to the solicitation will be given the opportunity to submit quotations for items contained in their response;

NOW, THEREFORE, BE IT RESOLVED that the County shall publish this notice in its official newspaper as provided in Resolution No. 95-41.

BE IT FURTHER RESOLVED that the above referenced vendor list is available for public inspection, and prospective vendors may request information packets, which must be completed in order to apply to be included on the available vendor list from the Lewis County Auditor's Office, Financial Services Department.
