TO ALL THROUGH TRAFFIC }

RESOLUTION NO. 12-1661

WHEREAS, as part of the Louisiana Avenue to Airport Road connection project, Lewis County plans to reconstruct Airport Road between Mile Posts 0.65 and 1.76; and

WHEREAS, it will be necessary to close Airport Road between Centralia City limits and the Chehalis City limits to all through traffic during the period of such work; and

WHEREAS, Airport Road will remain open for local access from either end, and other roads are available for detour; and

WHEREAS, it has been determined normal local businesses will be accommodated during this closure.

NOW THEREFORE, BE IT RESOLVED that pursuant to RCW 47.48.010 and 47.48.020, from May 29, 2012 to December 31, 2012, beginning at 7:00 A.M. on the first day of the closure and ending at 5:00 P.M. on the last day of the closure, Airport Road at the above described location, in Sections 18 and 19, Township 14 North, Range 2 West, W.M., shall be closed to all through traffic.



NOTICE

NOTICE IS HEREBY GIVEN that the Board of County Commissioners, Lewis County, Washington, approved the closure of Airport Road to all through traffic as it is necessary for Lewis County to reconstruct a portion of Airport Road as part of the Louisiana Avenue to Airport Road connection project between Mile Posts 0.65 and 1.76. Airport Road will be closed to all through traffic between the Centralia City Limits and the Chehalis City Limits during the period of such work. Airport Road will remain open for local access from either end up to but not beyond the point of closure, and other roads are available for detour. Pursuant to RCW 47.48.010 and 47.48.020, from June 4, 2012 to December 31, 2012 starting at 7:00 A.M. on the first day of closure and ending 5:00 P.M. on the last day of the closure Airport Road at the above described location, in Sections 18 and 19, Township 14 North, Range 2 West, W.M., shall be closed to all through traffic.
