RESOLUTION NO. 12-277

WHEREAS, it is necessary for Lewis County to replace an undersized culvert on North Military Road 200 feet south of the intersection of Koontz Road; and

WHEREAS, it will be necessary to close North Military Road to all through traffic between Koontz Road and Avery Road West during the period of such work; and


WHEREAS, North Military Road will remain open for local access up to but not beyond the point of closure, and other county roads are available for detour.

NOW THEREFORE, BE IT RESOLVED that pursuant to RCW 47.48.010 and 47.48.020, from September 4, 2012 to September 11, 2012 beginning at 7:00 A.M. on the first day of the closure and ending at 5:00 P.M. on the last day of the closure, North Military Road at the above described location, in Sections 1 and 2, Township 12 North, Range 2 West, W.M., shall be closed to all through traffic.


NOTICE

Pursuant to RCW 47.48.010 and 47.48.020, from September 4, 2012 to September 11, 2012 starting at 7:00 A.M. on the first day of closure and ending 5:00 P.M. on the last day of the closure, North Military Road at the above described location, in Sections 1 and 2, Township 12 North, Range 2 West, W.M., shall be closed to all through traffic.
