**WHEREAS**, pursuant to Resolution 14-306, the Board of County Commissioners (BOCC) adopted the 2015-2020 Transportation Improvement Program (TIP); and

**WHEREAS**, Lewis County's 3R Program is listed on the 2015-2020 TIP; and

**WHEREAS**, the BOCC wishes to chipseal approximately 78 miles of roadway and approximately 1.26 miles of cement treated base in Lewis County and needs to purchase Rock for Countywide Road Maintenance, and other work as directed by the Engineer; and

**WHEREAS**, pursuant to Resolution 14-111, the BOCC adopted the 2014 Standard Specifications for Road, Bridge, and Municipal Construction and this proposal shall be performed by contract in accordance with these specifications.





NOTICE IS HEREBY GIVEN that the Board of County Commissioners (BOCC) of Lewis County or designee, will open sealed bids and publicly read them aloud on or after 11:30 a.m. on January 6, 2015, at the Lewis County Courthouse, Chehalis, Washington, for the 2015 Rock Proposal.

11:00 a.m. on Tuesday, January 6, 2015**

(Lewis County official time is displayed on Axxess Intertel phones in the office of the BOCC. **Bids submitted after 11:00 a.m. will not be considered for this proposal.**)

Sealed bids must be delivered to the Clerk of the BOCC (351 N.W. North Street, Room 210, CMS-01, Chehalis, Washington 98532), by or before **11:00 a.m.** on the date specified for opening, and in an envelope clearly marked: **"SEALED BID FOR THE 2015 ROCK PROPOSAL, TO BE OPENED ON OR AFTER 11:30 A.M. ON, JANUARY 6, 2015."**


Each bid shall be in accordance with the plans, specifications, and other contract documents now on file with the County Engineer. The contract documents may be viewed and downloaded from Lewis County's website at [www.lewiscountywa.gov](http://www.lewiscountywa.gov) or you may call the Lewis County Engineers office at (360) 740-2612 and to request a copy.

Each bid shall be accompanied by a certified check, cashier's check or bid bond payable to the Treasurer of Lewis County in the sum of five percent (5%) of the bid to be forfeited to Lewis County by the successful bidder in case they fail to enter into contract and file an acceptable surety bond in the full amount of the bid to fill conditions of said contract within twenty (20) calendar days of the date of award.

The Lewis County Public Works Department in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, subtitle A, Office of the Secretary, Part 21, nondiscrimination in Federally assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises as defined at 49 CFR Part 26 will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.

The BOCC reserves the right to reject any or all bids and to waive all informalities in the bidding.
