



SCOPE OF WORK

Publish Lewis County legal notices using 8-point type in 1.20 column inch.

SELECTION CRITERIA

The lowest responsible bidder will be selected on the following criteria: cost per column inch using 8-point type; total circulation figures for the year 2014; paid circulation figures for the year 2014; the availability of a website (this meets new requirements established in the Revised Code of Washington regarding bidding laws); total number of hits on the website for the month of January, 2015; the website address; and the quality of the sample notice returned and the price of the sample returned. Bidders are asked to complete the attached bidder form and attach sample.


