WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to replace a culvert on Ceres Hill Road at Mile Post 5.82; and

WHEREAS, it will be necessary to close Ceres Hill Road between Bunker Creek Road and Meskill Road to all through traffic during the period of such project work; and

WHEREAS, Ceres Hill Road will remain open for local access from either end up to but not beyond the point of closure at Mile Post 5.82, and other county roads are available for detour.

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW 47.48.010 and .020, beginning 7:00 a.m., August 24, 2015, and ending 5:00 p.m., October 6, 2015, Ceres Hill Road between Bunker Creek Road and Meskill Road, in Sections 6 and 7, Township 13 North, Range 3 West, W.M., and Sections 11 and 12, Township 13 North, Range 4 West, W.M., shall be closed to all through traffic.


