WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to repair a bridge on Ingalls Road at MP 2.11; and

WHEREAS, it will be necessary to close Ingalls Road between Lincoln Creek Road and Bunker Creek Road to all through traffic during the period of such project work; and

WHEREAS, Ingalls Road will remain open for local access from either end up to but not beyond the point of closure at MP 2.11, and other county roads are available for detour

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, beginning 7:00 a.m., September 21, 2015, and ending 5:00 p.m., October 16, 2015, Ingalls Road between Lincoln Creek Road and Bunker Creek Road, in Sections 4 and 9, Township 14 North, Range 4 West, W.M., shall be closed to all through traffic.


