The Lewis County Sheriff's Office is releasing the following information pursuant to RCW 4.24.50, which authorizes law enforcement agencies to inform the public when the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the Sheriff's Office. Further, their previous history places them in a classification level that reflects the potential to re-offend. The individual served the sentence imposed by the court and has properly notified the Sheriff's Office of their current address. The law does not require this offender to do anything other than register. **THEY ARE NOT WANTED BY LAW ENFORCEMENT AT THIS TIME. Synopsis of Information: In 2008 Pries was convicted in Lewis County Superior Court of Luring with Sexual Motivation. The crime involved Pries having contact with a young teenage male that included acts that were of a sexual manner. As a result of that conviction Pries was sentenced to 18 months in prison. He was released on 02/09/09 and remains on Department of Corrections supervision. In 1985 Pries was involved in the same type of behavior, also involving a young teenage male. That case was not charged, but handled as a probation violation related to non-sexual felony conviction.

Based on his continued predatory behavior he has been identified as a clear risk to the community and this notification is required.

Using this public information to threaten, intimidate or harass sex offenders will not be tolerated by the law enforcement agencies of Lewis County. This abuse could potentially terminate our ability to release this important information to the public.
