Draft Programmatic Environmental Impact Statement

The Chehalis Basin has experienced both major flooding and substantial degradation of aquatic species habitat. These issues have persisted for almost 100 years without a comprehensive response.

The Department of Ecology is considering potential actions to reduce flood damage and restore habitat for aquatic species. The Chehalis Basin Strategy includes near and long term actions, as well as small and large scale projects.
