
WHEREAS, said application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings.

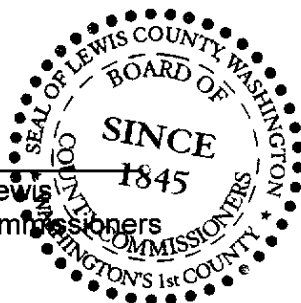

NOTICE IS HEREBY GIVEN that the Board of County Commissioners, Lewis County, Washington (BOCC), has received an application for a non-exclusive license from Sprint Communications Company L.P., to replace their existing license which is scheduled to terminate in October, 2017, to construct, operate and maintain telecommunication facilities on, under and across Highway 603 between the City of Napavine and Shorey Road in Sections 8, 16, 17, 21, 27 & 28, Township 13 North, Range 2 West, W.M.


The license being considered is for a period of five years.

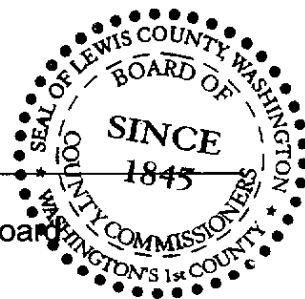
The application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings.

A hearing on the non-exclusive franchise will be held on the 9th day of October, 2017, at or after the hour of 10:00 a.m., in the Commissioners Hearing Room on the 2nd floor of the Historic Courthouse in Chehalis, Washington, when and where all persons may appear and be heard upon the granting of the franchise.

RCW 36.55.040 requires that notice of hearing be posted in three public places in the county seat of the county at least 15 days before the day fixed for hearing, and also published two times in the official newspaper of the county, the last publication to be not less than 5 days before the day fixed for hearing.
