WHEREAS, The Board of County Commissioners (BOCC), in conjunction with the adoption of amended statewide regulations, finds it necessary to amend the appropriate sections of the Lewis County Building Code as codified under Ch. 15.05 LCC; and

WHEREAS, under revised code of Washington RCW Section 36.32.120(7) Powers of Legislative Authority, the BOCC is required to hold a public hearing on any proposed code change prior to the revision of the Lewis County Code (LCC), and LCC section 1.05.010 provides the process used by the BOCC to modify the County Code.



The amendments incorporate changes to reflect 2015 International Building Codes (IBC) and International Code Council (ICC), as set forth in Chapter 51 WAC.

All persons wishing to be heard on this matter are encouraged to attend. Written comments may be submitted in advance of the hearing by mail or at the hearing by delivery in person.
