WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to perform a bank protection project on Senn Road at mile post 0.89; and

WHEREAS, it will be necessary to close Senn Road between Lucas Creek Road and Centralia Alpha Road to all through traffic during the period of such project work; and

WHEREAS, Senn Road will remain open for local access from either end up to but not beyond the point of closure at Mile Post 0.89, and other county roads are available for detour.

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, from September 6, 2016 and October 31, 2016, Senn Road between Lucas Creek Road and Centralia Alpha Road, in Sections 2, Township 13 North, Range 1 West, W.M., shall be closed to all through traffic.




NOTICE
