**WHEREAS**, the Friends of the Mountain View Timberland Library in Randle are planning an event on Silverbrook Road between MP .064 and MP.074; and


**WHEREAS**, to facilitate the event it will be necessary to close Silverbrook Road to through traffic between Boyd Road and McKay Street to all through traffic; and

**WHEREAS**, the Silverbrook Road will remain open for local access from either end up to but not beyond the points of closure, and other county roads are available for detour.

**NOW THEREFORE, BE IT RESOLVED** that, pursuant to RCW 47.48.010 and .020, that effective July 19, 2016, from 1:00 p.m. to 5:00 p.m. the area of Silverbrook Road described above in Section 8, Township 12 North, Range 7 East, W.M., shall be closed to all through traffic.




