WHEREAS, it will be necessary to close Toledo Salmon Creek Road at Mile Post 4.35 and beyond to all traffic until the slide area has been repaired and deemed safe for travel; and

WHEREAS, Toledo Salmon Creek Road will remain open for local access up to but not beyond the points of closure at Mile Post 4.35.

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, beginning 12:00 a.m., May 8, 2017, and ending 6:00 p.m., May 8, 2018, Toledo Salmon Creek Road at Mile Post 4.35, in Section 34, Township 11 North, Range 1 West, W.M., shall be closed to all through traffic.
