WHEREAS, it is necessary for Lewis County to replace a culvert on Lakeside Drive at milepost 0.22; and

WHEREAS, Resolution 17- 247 closed Lakeside Drive for the culvert replacement project between September 5, 2017 through September 13, 2017; and


WHEREAS, it will be necessary to extend the closure of Lakeside Drive between Streamside Drive and Lake Drive to all through traffic to complete such project work; and

WHEREAS, Lakeside Drive will remain open for local access from either end up to but not beyond the point of closure at milepost 0.22, and other county roads are available for detour.


NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, beginning September 14, 2017 and ending September 29, 2017, Lakeside Drive between Streamside Drive and Lake Drive, in Section 28, Township 12 North, Range 2 East, W.M., shall be closed to all through traffic.

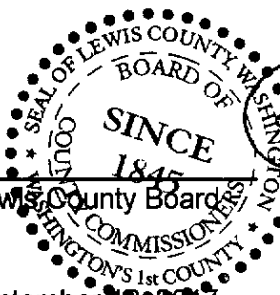

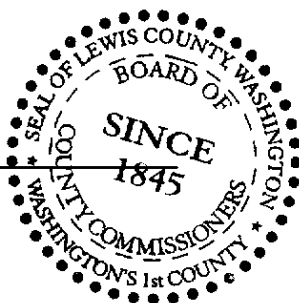
NOTICE OF HEARING

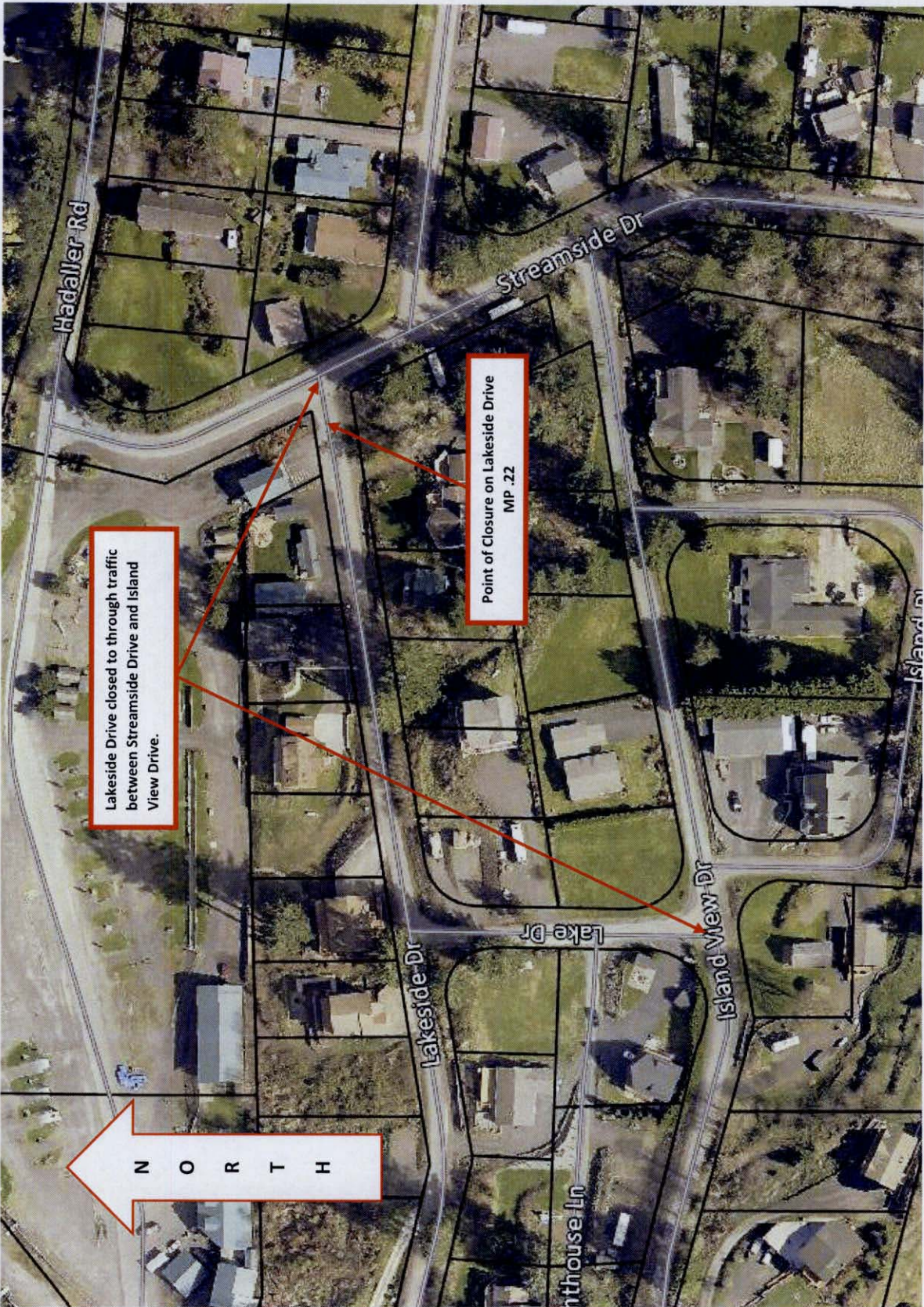
