RESOLUTION NO. 17-240

WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to repair a bridge on Oyler Road at mile post 3.24; and

WHEREAS, it will be necessary to close Oyler Road between Boone Road and Jackson Highway to all through traffic during the period of such project work; and

WHEREAS, Oyler Road will remain open for local access from either end up to but not beyond the point of closure at Mile Post 3.24, and other county roads are available for detour

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, beginning August 28, 2017 and ending October 31, 2017, Oyler Road between Jackson Highway and Boone Road, in Sections 15, 16, 21 and 22, Township 12 North, Range 1 West, W.M., shall be closed to all through traffic.

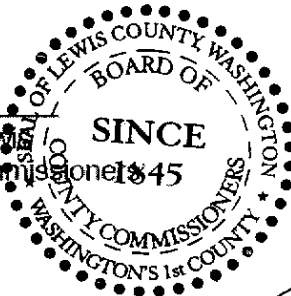

**NOTICE IS HEREBY GIVEN** that the Board of County Commissioners, Lewis County, Washington, has approved the temporary closure of a portion of Oyler Road between Jackson highway and Boone Road, to all through traffic. During the closure the road will remain open to local access from either end up to but not beyond the point of closure at milepost 3.24, and other county roads are available for detour. Pursuant to RCW 47.48.010 and .020, effective August 28, 2017 through October 31, 2017 that portion of Oyler Road described above in Sections 15, 16, 21 and 22, Township 12 North, Range 1 West, W.M., shall be closed to all through traffic.

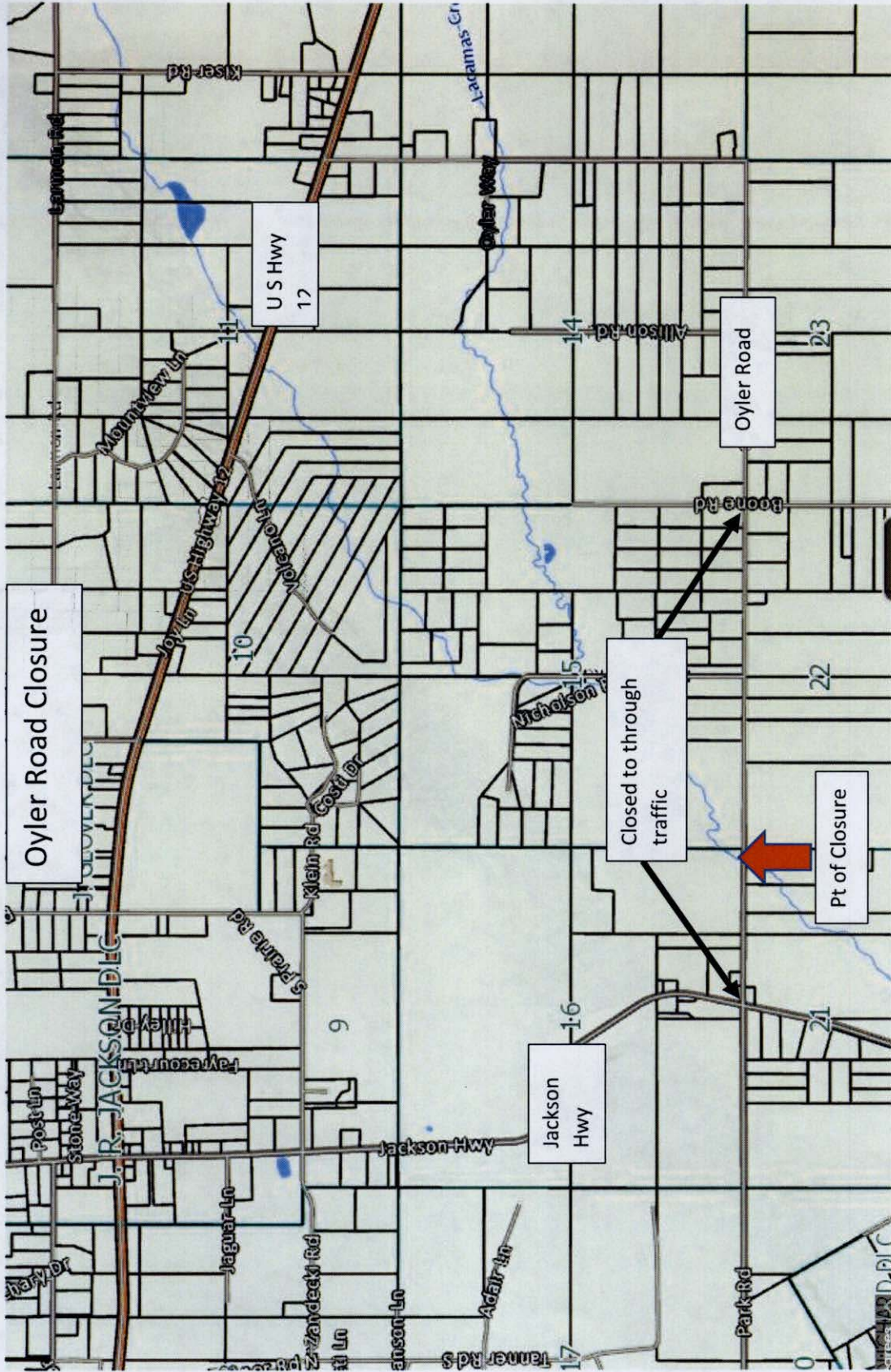
