WHEREAS, the loss of life and property can be significantly reduced as appropriate disaster preparedness measures are taken before, during, and after a disaster; and

WHEREAS, County agencies and employees should be prepared so they can continue to provide essential public services after a disaster, and support the state's disaster response and recovery mission; and

WHEREAS, the importance of practicing preparedness will be highlighted during the month of April as the Washington State Military Department, Lewis County Sheriff's Office, Division of Emergency Management, businesses, educational institutions, service organizations and other city / county agencies promote the value of preparedness activities; and

WHEREAS, the County is encouraging Lewis County citizens to participate in the statewide earthquake drill on April 25, 2012;

NOW THEREFORE, we, the members of the Lewis County Board of County Commissioners do hereby proclaim April 2012 as

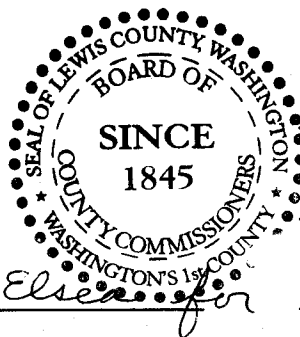
