WHEREAS, pursuant to Resolution 18-116, the BOCC adopted the 2018 Standard Specifications for Road, Bridge, and Municipal Construction and this proposal shall be performed by contract in accordance with these specifications.

NOW THEREFORE BE IT RESOLVED that the Department of Public Works is instructed to issue a Call for Bids and Contract Specifications for the 2020 Rock Proposal. North Street, Room 210, CMS-01, Chehalis, Washington 98532) by or before 11:00 a.m. on Tuesday, November 12, 2019 and will be opened on or after 11:00 a.m. on November 12, 2019..
