#### **Business Meeting minutes**

Commissioner Swope called the meeting to order at 10 a.m., determined a quorum and then proceeded with the flag salute.

## **PUBLIC COMMENT**

Rieva Lester noted that Kyle Wheeler had submitted written comment.

## **NOTICE ITEM**

Commissioner Pollock made a motion to approve Resolution 23-001. Commissioner Brummer seconded.

Resolution 23-001: Establishment of 2023 county road construction projects by County Forces.

**Public Works Director Josh Metcalf** discussed the resolution. Josh said the county is required to notice County Forces projects that exceed \$10,000 in value.

Motion passed 3-0.

# **CONSENT ITEMS**

Commissioner Brummer made a motion to approve minutes from the December 27, 2022, Business Meeting as well as Resolution 23-002. Commissioner Pollock seconded.

Resolution 23-001: Approval of warrants/claims against the various county departments.

Chief accountant Grace Jimenez, representing the Auditor's Office, said warrants 864,148 through 864,278 and direct disbursements numbered 10934 through 10935 were issued in December for payments against the county totaling \$392,232.85. She said payroll/tax deposit warrants 795,992

through 795,994 and Automatic Deposits numbered 48,623 through 49,200 also were approved for payments totaling \$1,199,968.79.

Motion passed 3-0.

## **DELIBERATION ITEMS**

Commissioner Pollock made a motion to approve Resolutions 23-003 through 23-006. Commissioner Brummer seconded.

Resolution 23-003: Accept an amendment to an agreement between the Lewis County Sheriff and Naphcare, Inc.

**Chief Chris Sweet** discussed the resolution. Chief Sweet said the agreement provides for one additional nightshift nurse and provides cost-of-living adjustments.

Resolution 23-004: Approve CPWI Prevention Amendment 4 between Washington Health Care Authority (HCA), Division of Behavioral Health and Recovery (DBHR) and Lewis County Public Health and Social Services (PHSS).

**Community Health Services & Contracts Coordinator Sara Bumgardner** discussed the resolution. Sara said the amendment increases the funding for the prevention coalitions in Morton in Centralia.

Resolution 23-005: Authorize an application for a Rapid Capital Housing Acquisition grant to reimburse the purchase of 1258 SE Washington Ave., Chehalis.

**Housing and Infrastructure Specialist Eric Eisenberg** discussed the resolution. Eric said the county has completed its purchase of 1258 SE Washington Ave. in Chehalis the previous week and that the resolution authorizes him to seek grants to cover the costs.

Resolution 23-006: Approve a grant amendment with the Washington State Broadband Office.

**Budget Administrator Becky Butler** discussed the resolution. Becky said the resolution reflects updated language in the county's agreement with ToledoTel.

Motion passed 3-0.

Commissioner Pollock made a motion to approve the McDonald v. Albright settlement agreement as discussed in executive session. Brummer seconded. Motion passed 3-0.
