Administrator succession planning

Erik Martin offered to stay on with the Chehalis River Basin Flood Control Zone District as the administrator. Erik said there would need to be a statement of re-delegation if he continues to stay on to do the administrative work. Erik is willing to submit a contract discussing his scope of work. J Vander Stoep said it would make sense for Erik to continue if able. John Henricksen said bringing an outside person up to speed would be difficult and suggested that he recommended Erik stay onboard. Frank Corbin concurred. Erik Martin said he would come to the full Board of Supervisors with a contract and a full scope of work.

Project Update

Matt Dillin said the District's consultant team is recommending that the District advance the analysis on the upstream minimization alignment. Matt said that with the information available to the District, the team believes the upstream alignment does a better job at minimizing impacts to an important TCP. Early investigations by

the District's engineers indicate that both alignments appear feasible and would allow for free flowing bypass during construction. Supervisor Swope made a motion to approve to direct staff to advance the upstream alignment. Supervisor Brummer seconded.

Motion passed 2-0

Erik said access permits have been acquired from Weyerhaeuser for the current work. However, he said more work is needed in the next phase of the project and obtaining additional access permits will be needed. Frank asked if acquisition and additional trees would be needed and Erik feels additional groundwork is needed.

OCB Update

Edna Fund said \$73 million was originally requested of legislature. Edna said HB6639 is a bill she is currently watching.
