

The Lewis County Sheriff's Office is releasing the following information pursuant to RCW 4.24.50, which authorizes law enforcement agencies to inform the public when the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the Sheriff's Office. Further, their previous history places them in a classification level that reflects the potential to re-offend. The individual served the sentence imposed by the court and has properly notified the Sheriff's Office of their current address. The law does not require this offender to do anything other than register. THEY ARE NOT WANTED BY LAW ENFORCEMENT AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC. Synopsis of Information: Documentation shows that Jacobe was convicted of Indecent Liberties in Lewis County Superior Court on 10/25/99. The offense involved Jacobe having sexual contact with a 14year-old female who was spending the night at a friend's house at the same time that Jacobe was also staying at the residence. As a result of the conviction, Jacobe was sentenced to 18 months of confinement in prison. He was initially released from prison on 11/30/00. On 10/28/03, Jacobe pled guilty to the offense of Assault of a Child 3rd Degree with Sexual

Motivation. This crime involved the sexual assault of a 7-year-old female that took place before his sentencing on the prior case. He will be released from prison on 07/01/04 and will be under Department of Corrections Community supervision. He has been categorized as a Level III Offender and this community notification is required.

Using this public information to threaten, intimidate or harass sex offenders will not be tolerated by the law enforcement agencies of Lewis County. This abuse could potentially terminate our ability to release this important information to the public.
