I, DAVID K. TOYER, do declare or certify under the laws of the state of Washington that the following is true and correct:

- 1. I am the President of Toyer Strategic Advisors, Inc., a land use and economic development consultancy in Lake Stevens, Washington.
- 2. I have over 20 years of experience in land use and economic development, which experience includes consulting on annexations.
- 3. In personally consulting on six (6) annexations since 2018, I have been responsible for preparing and submitting Notices of Intent to Annex ("NOI") on five (5) occasions, which NOIs have been filed with boundary review boards in King, Snohomish, and Lewis counties. And on

two (2) occasions, I substantively contributed to the preparation of each NOI prior to each NOI being filed by other parties in Snohomish and Lewis counties.

- 4. The triggering event for commencement of the 45-day review period in which jurisdiction of a boundary review board may be invoked, is the establishment of an Effective Filing Date. Once a boundary review board establishes the Effective Filing Date and the 45-day review period commences, a boundary review board should route the NOI to other governmental units, special purpose districts, etc.
- 5. Of the four (4) annexations completed within King and Snohomish counites, the average time elapsed between submission of the NOI to a boundary review board and establishment of the Effective Filing Date was approximately thirteen (13) days—nine (9) days for the Fagerlie annexation; ten (10) days for the Pellerin annexation; fifteen (15) days for the 320th Street annexation, and nineteen (19) days for the Rhodora annexation.
- 6. In all four (4) annexations described above, the time elapsed included: (i) deeming the NOI "legally sufficient"; (ii) establishing the Effective Filing Date which commences the 45-day review period (in which jurisdiction of the Boundary Review Board may be invoked); and (iii) routing the NOI to other governmental units, special purposes districts, etc.
- 7. Of the two (2) annexations I've been involved with in Lewis County, the time elapsed between the initial submittal of the NOI and establishment of an Effective Filing Date was: (i) approximately eighty (80) days for the City of Centralia West Reynolds annexation; and (ii) sixty-five (65) days for the City of Winlock annexation (NOI filed on September 28, 2022, and Effective Filing Date established on December 1, 2022).
- 8. In each of the Lewis County annexations, the Boundary Review Board did not acknowledge the requirement of commencing the 45-day period (in which jurisdiction may be invoked) upon

establishment of the Effective Date of Filing. Rather, for the City of Centralia West Reynolds annexation, an additional thirty-seven (37) days elapsed before the Boundary Review Board "declared" commencement of the 45-day period. And, for the City of Winlock annexation, an additional forty-two (42) days elapsed before the Boundary Review Board "declared" commencement of the 45-day period.

9. In each of the Lewis County annexations, the total time elapsed between the filing of the NOI and the Boundary Review Board "declaring" commencement of the 45-day review period was: (i) one hundred seventeen (117) days for the City of Centralia West Reynolds annexation; and (ii) one hundred seven (107) for the City of Winlock annexation.
