#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Lewis County from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the County. We also determined whether the County complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- Revenue and expenditure analytical procedures
- Cash receipting
- Treasurer's Office
- On-call contracting

- Third-party cash receipting
- Credit cards
- Purchase cards
- Fuel cards
- Pavroll
- Financial condition

### **RESULTS**

In most areas, the County complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to County management. We appreciate the County's commitment to resolving those matters.

#### **FINANCIAL**

Our opinion on the County's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the County's financial statements.

### FEDERAL GRANT PROGRAMS

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the County's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report. That report includes two federal findings regarding the following:

- The County did not have adequate internal controls over its Child Support Enforcement grant to ensure compliance with federal allowable cost requirements.
- The County's internal controls over the Title III portion of its Schools and Roads grant were inadequate to ensure purchases were for allowable purposes.

#### **ABOUT THE COUNTY**

Lewis County is home to more than 75,900 residents. Historically a logging and agricultural county, Lewis County's economy is in transition. The County is moving towards a more diversified economy including construction, manufacturing, retail, healthcare, transportation and warehousing, utilities and public employment sectors.

An elected, three-member Board of Commissioners administers the County, which operates on a \$109.3 million annual budget. Its 588 full- and part-time employees provide sheriff and court services, construction and maintenance of roads and bridges, health and social services, cultural and recreational facilities and services, planning and zoning services and general administrative services.

### **AUDIT HISTORY**

We audit the County annually. The 2008 audit contained a federal finding regarding internal controls over Davis Bacon Act (prevailing wage) requirements. The 2009 audit was free of findings and previous findings had been resolved. The 2010 audit reported a finding for inadequate internal controls over preparation of the Schedule of Expenditures of Federal Awards. That finding has been resolved. The 2011 audit and current audit are free of accountability audit findings.
