**TPN:** NON-PROJECT ACTION – RV Park and Campground Code Amendments

**Applicant's Name:** Lewis County Community Development Department (Mindy Brooks)

**Project Description:** Amendments to LCC Titles 15, 16, and 17. The proposed code amendments would change the process to approve a new RV park or campground from a Binding Site Plan to a Special Use Permit process. In addition, new standards are included to allow no more than 25% of the camping sites to be occupied by a cabin or yurt, with a maximum size of structure set at 400 square feet. The amendments also increase the allowed length of stay from 180 days to 210 days. The amendments allow for one camping site to be occupied by caretaker accommodation, which are not subject to the length of stay limitation and may be up to 1,296 square feet in size. The amendments also allow for accessory uses within the RV Park/Campground, such as a convenience store, and clarify the screen and buffering requirements. The amendments do not change the zones within which RV parks and campgrounds are allowed.
