#### NOTICE OF HEARING

NOTICE IS HEREBY GIVEN that the Board of County Commissioners, Lewis County, Washington (BOCC), has received an application for a non-exclusive franchise from McDaniel Telephone Co., d/b/a TDS Telecom to install, construct, operate, and maintain telecommunications facilities located within Lewis County road right of way in the following locations:

Portions of Sections 1-2, 11-14, 23-24, Township 12 North, Range 1 West, W.M.. Sections 4-9,16-20 in Township 12 North, Range 1 East, W.M.. Sections 3-36 in Township 12N, Range 2 East, W.M..
