WHEREAS, said application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings.

NOW THEREFORE BE IT RESOLVED the hearing of the franchise will take place in the Commissioners' Hearing Room on the 2nd floor of the Historic Lewis County Courthouse in Chehalis, Washington, at or after 10 a.m., on the 10th day of October 2023, when and where all persons may appear and be heard upon the programs, and that the Clerk of the BOCC is hereby instructed to proceed with all necessary notifications, posting and publication.

NOTICE OF HEARING

NOTICE IS HEREBY GIVEN that the Board of County Commissioners, Lewis County, Washington (BOCC), has received an application for a non-exclusive franchise from Glenn & Kathleen Hedrick install, construct, operate, and maintain water facilities located within Lewis County road right of way in the following locations:

Chilvers Road from a point 100 feet East of Dieckman Road, West for 500 feet. All lying within Section 4, Township 13N, Range 3 West, W.M. all lying within Lewis County, Washington.

The franchise being considered is for a period of ten years.

The application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings. A hearing on the non-exclusive franchise will be held on October 10, 2023, at or after 10 a.m., in the Commissioners' Hearing Room on the 2nd floor of the Historic Courthouse in Chehalis, Washington, when and where all persons may appear and be heard upon the granting of the franchise. Interested parties are encouraged to check the Commissioners' hearing schedule online at <https://lewiscountywa.gov/offices/commissioners/agendas-calendar/> for updated details as the hearing date approaches.

RCW 36.55.040 requires that notice of hearing be posted in three public places in the county seat of the county at least 15 days before the day fixed for hearing, and also published two times in the official newspaper of the county, the last publication to be not less than 5 days before the day fixed for hearing.
