**WHEREAS**, pursuant to Resolution 15-339, the Lewis County Board of County Commissioners approved and ratified a Community Development Block Grant (CDBG) Agreement No. 15-62210-026 for \$717,000 for construction of a new potable water reservoir; and

**WHEREAS**, a public hearing to assess the project performance is required by the Washington Department of Commerce as part of the closeout and final payment process; and

**WHEREAS**, Lewis County is inviting public participation for the purpose of receiving testimony on the performance of the Community Development Block Grant used to construct the new potable water reservoir.

**NOW THEREFORE BE IT RESOLVED** that December 30, 2019, at or after the hour of 10:00 am, in the Commissioners Hearing Room on the 2nd floor of the Historical Courthouse in Chehalis, Washington, has been fixed by the Board as the time and place for the hearing for the purpose of receiving testimony on the performance of the Community Development Block Grant used to construct the Vader-Enchanted Valley potable water reservoir. The Clerk of the Board is hereby instructed to proceed with all appropriate and necessary notifications, posting and publication as required by RCW 65.16.160.

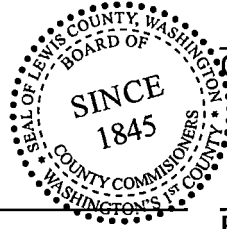
