Portions of Sections 1-11, 16-18, Township 11 North, Range 2 West, W.M.. Portions of Sections 1-2,11-12, 13-14 in Township 11 North, Range 3 West, W.M.. Portions of Sections 7, 18, 19 &30 in Township 12N, Range 1 West, W.M.. Portions of Sections 5-36 in Township 12 North, Range 2 West, W.M.. Portions of Sections 1, 12, 13, 24, 25 & 26 in Township 12 North, Range 3 West, W.M.. All lying within Lewis County, Washington.

The franchise being considered is for a period of ten years.

The application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings. A hearing on the non-exclusive franchise will be held on February 13, 2024, at or after 10 a.m., in the Commissioners' Hearing Room on the 2nd floor of the Historic Courthouse in Chehalis, Washington, when and where all persons may appear and be heard upon the granting of the franchise. 
