    - The SWAC sub-committee met on October 5, 2023, to review the 2024 Solid Waste budget presentation. Terry Harris, Jason Adams, and Tom Rupert approved the budget.

#### B. Reports/Updates:

- SWAC Terry Harris Chair.
  - $\circ$   $\quad$  Thanked the Solid Waste staff for their work on the budget process.
- LeMay/Waste Connections Tom Rupert, District Manager, for LeMay Enterprises, Inc.
  - Still waiting for the truck for the East Lewis County project. Hoping the truck will come around December 15, 2023.
- Department of Ecology Laura Busby, Grants and Planning.
  - Waste Not Washington School Awards are available. Application times are now through October 31, 2023. These \$5000 awards are available to schools that are engaged in any kind of effort to reduce waste, recycle, and teach related environmental curriculum.
  - SWANA is offering a Moderate Risk Waste (MRW) technical session on October 26, 2023, in Ellensburg.
  - There are business organics outreach tool kits available.
  - June 1, 2024, polystyrene packing peanuts and void fill are banned from distribution in Washington State. Additional polystyrene products will also be banned including portable coolers and Styrofoam containers.
- Code Enforcement Brian Warren, Lewis County Code Enforcement Manager None.
- Lewis County Solid Waste Rocky Lyon, Solid Waste Manager.
  - Community Litter Program Report August.
    - The litter program coordinator and crew spent a total of 127.5 hours cleaning up 41 miles of roadway and 1,540 pounds of litter. This resulted in \$216.58 in fees.
    - The litter program coordinator and crew spent a total of 42 hours cleaning up 4 illegal dumpsites, removing 320 pounds of garbage, \$337.61 in fees.
    - Lewis County contracted litter crew roadside reported spending 22 hours cleaning up 520 pounds of litter resulting in \$3,031.94 in labor and disposal fees.
    - Volunteers in Centralia and throughout Lewis County spent 142.5 hours removing 194 bags of litter.
  - Transfer Station Tonnage August.
    - The combined monthly tonnage was 8,376.
    - YTD combined tonnage was 60,309 which is 66% of the estimated 92,000 tonnage.
  - There are two community tire recycling events coming up. One will be in Packwood and the second will be at the Fairgrounds. Code will be there to help at both.




