RESOLUTION NO. 24-192

THE EXTENDED CLOSURE OF LOGAN HILL ROAD
TO ALL THROUGH TRAFFIC AT MILEPOST 0.103

WHEREAS, RCW 47.48.010 provides that the county legislative authority may close road for a period of time during construction; and

WHEREAS, as part of County Maintenance Project No. 1805, placement of box culvert at Berwick Creek is planned ; and

WHEREAS, to facilitate placement of the culvert it will be necessary to close Logan Hill Road between Armstrong Road at MP 0.09 to MP 0.22 during construction; and

WHEREAS, Logan Hill Road will remain open for local access up to, but not at the points of closure, and alternate routes (Yates Road) will be available to detour the closure area.

NOW THEREFORE BE IT RESOLVED that pursuant to RCW 47.48.010 and .020, beginning July 1, 2024, and ending before October 25, 2024, Logan Hill Road at MP 0.103 shall be closed to all through traffic.
