#### **Administrative Report:** Kevin Engelbertson

Corrections Bureau – We currently have seven vacancies in the Corrections Bureau and one Corrections Lieutenant vacancy. One employee that was on extended temporary modified duty for a job-related injury is now out on extended medical leave. The two that were on FMLA have returned with one returning to temporary modified duty. Corrections Deputy Cameron Steepy resigned effective June 16<sup>th</sup> and Corrections Deputy Nathanial Gluck was hired effective June 1<sup>st</sup>. An offer of casual employment was given to Matthew Morton effective June 16<sup>th</sup>. We have two applicants in the background process.

Operations Bureau – Our two trainee deputies who graduated from the basic law enforcement academy on May 21<sup>st</sup> are progressing in their FTO. The two trainee deputies attending the BLEA at the Burien campus are in week ten and progressing well. Sergeant Curt Spahn is retiring effective July 1<sup>st</sup>. Deputy Andrew Yocom was promoted to Patrol Sergeant effective June 2<sup>nd</sup>. Two additional deputies will be promoted during the month of July. Two deputies are

out on FMLA. Several panel interviews are being held this week for the position of Deputy. Two new members of our Swift Water Rescue Team attended a three-day training session to learn lifesaving rescue techniques last week. Our team is better prepared for rescues both on the waterways and during flood events. K9 Kimbo and Deputy Kasinger are back from training and hitting the ground running. During K9 Kimbo's first week on the job, he alerted on a vehicle for drugs. A search warrant was issued, and it resulted in the recovery of over 41 grams of methamphetamine and a meth pipe.

Services Bureau – Our Support Technician 1 on probationary employment is progressing well in her training.

We may be creating two CSO positions. Details are being worked out with the BOCC.

#### **Other Business:**

Commissioner Faupell reported she attended the BOCC meeting on Monday and they approved moving forward with the hiring process for the one applicant to the vacant board position. Commissioner Ryan requested they interview the candidate. Both Commissioner's would still like to be part of the interview process. Linda will convey this to the BOCC.
