PROJECT: A variance to reduce the 150-foot shoreline buffer of Big Creek to construct a single-family residence with associated utilities and new gravel driveway. The variance request is to reduce the 150-foot shoreline buffer to 36 feet for the residence and 81 feet for the septic drainfield. A No Net Loss of Ecological Function Report and Mitigation Plan has been prepared for the reduced setback from Big Creek.

Persons on the notice of application mailing list will be sent a public hearing notice, as will any other persons that provide written comments during the public 30-day notice of application comment period.
