 - o Community Litter Program Report April.
 - The litter program coordinator and crew spent a total of 152 hours cleaning up 62 miles of roadway and 2,420 pounds of litter. This resulted in \$192.00 in fees.
 - The litter program coordinator and crew spent a total of 95 hours cleaning up 9 illegal dumpsites, removing 2,980 pounds of garbage, \$491 in fees.
 - City of Centralia interchanges and intersections reported spending 69 hours cleaning up 1,230 pounds of litter resulting in \$1,510 in disposal fees.
 - Volunteers in Centralia and throughout Lewis County spent 112 hours removing 119 bags of litter.
 - Transfer Station Tonnage April.
 - The combined monthly tonnage was 8,114.
 - YTD combined tonnage was 29,586 which is 35% of the estimated 85,000 tonnage.
 - Solid Waste Management Plan.
 - Comments were received from the Department of Ecology. We will share the comments with the SWAC for their input and will go over SWAC's comments at the August 14, 2024, meeting.


