**WHEREAS**, Lewis County Code, Chapter 3.30, Management and Disposition of Property requires the Board of County Commissioners (BOCC) to declare such property surplus prior to disposal under said Code; and

**WHEREAS**, the listing of property attached as Exhibit A and Exhibit B has been recommended as surplus to the County's needs by the Public Works Fleet Division; and

**WHEREAS**, property listed on Exhibit A will be sold online at GovDeals.com, and property listed on Exhibit B will be sold at Ritchie Bros. Auction - 214 Ritchie Lane in Chehalis - at 8 a.m. Sept. 27.

**NOW THEREFORE BE IT RESOLVED** that the Public Works Fleet Division is authorized to dispose of the listed items with an estimated value of less than \$5,000.00 in compliance with Lewis County Code, Chapter 3.30; and

**NOW THEREFORE BE IT FURTHER RESOLVED** that for the listed items with an estimated value of \$5,000.00 or more (hereinafter "Item"), the estimated value for each Item is as set forth in Exhibit A and Exhibit B, sale of each Item is most advantageous to the County, and the Public Works Fleet Division is directed to publish notice of sale of each Item and sell each Item at public sale pursuant to Lewis County Code 3.30.290.
