VII. **BUSINESS AGENDA:**

A. **New Business:**

- a. Solid Waste Management Plan update - Comments are back from the Department of Ecology and were shared with the SWAC members. Herrera is working to finalize the Plan draft.

- b. 2025 Budget – A SWAC sub-committee is needed to help during budget season. Terry Harris, Jason Adams and Tom Rupert volunteered. Robert Spahr will be a back-up participant if needed.

B. Reports/Updates:

- SWAC – Terry Harris – Chair – None.
- WSU Extension – Jason Adams – Repair Fair will be at Centralia College on September 21, 2024.
- LeMay/Waste Connections – Tom Rupert, Regional Manager, for LeMay Enterprises, Inc. – None.
- Department of Ecology – Christina Kullberg, Grants and Planning.
 - Department of Ecology has released ROCS (Recycling and Organics Characterization Study). The study was done over 2022-2023 and covers both recycling and organic waste streams.
- Code Enforcement – Brian Warren, Lewis County Code Enforcement Manager – None.
- Utility Transportation Commission – Steven Peters and Nicole Foster introduced themselves. They are investigators focusing on waste transporters without permits. If you have any questions or to report an illegal hauler, please email them at reportillegalhauler@utc.wa.gov.
- Lewis County Solid Waste – Rocky Lyon, Solid Waste Manager.
 - Community Litter Program Report – June.
 - The litter program coordinator and crew spent a total of 141 hours cleaning up 39 miles of roadway and 2,260 pounds of litter. This resulted in \$187.00 in fees.
 - The litter program coordinator and crew spent a total of 20 hours cleaning up 3 illegal dumpsites, removing 660 pounds of garbage, \$52 in fees.
 - City of Centralia interchanges and intersections reported spending 69 hours cleaning up 100 pounds of litter resulting in \$1,510 in disposal fees.
 - Volunteers in Centralia and throughout Lewis County spent 35 hours removing 86 bags of litter.
 - Transfer Station Tonnage – June.
 - The combined monthly tonnage was 7,303.
 - YTD combined tonnage was 45,135 which is 53% of the estimated 85,000 tonnage.

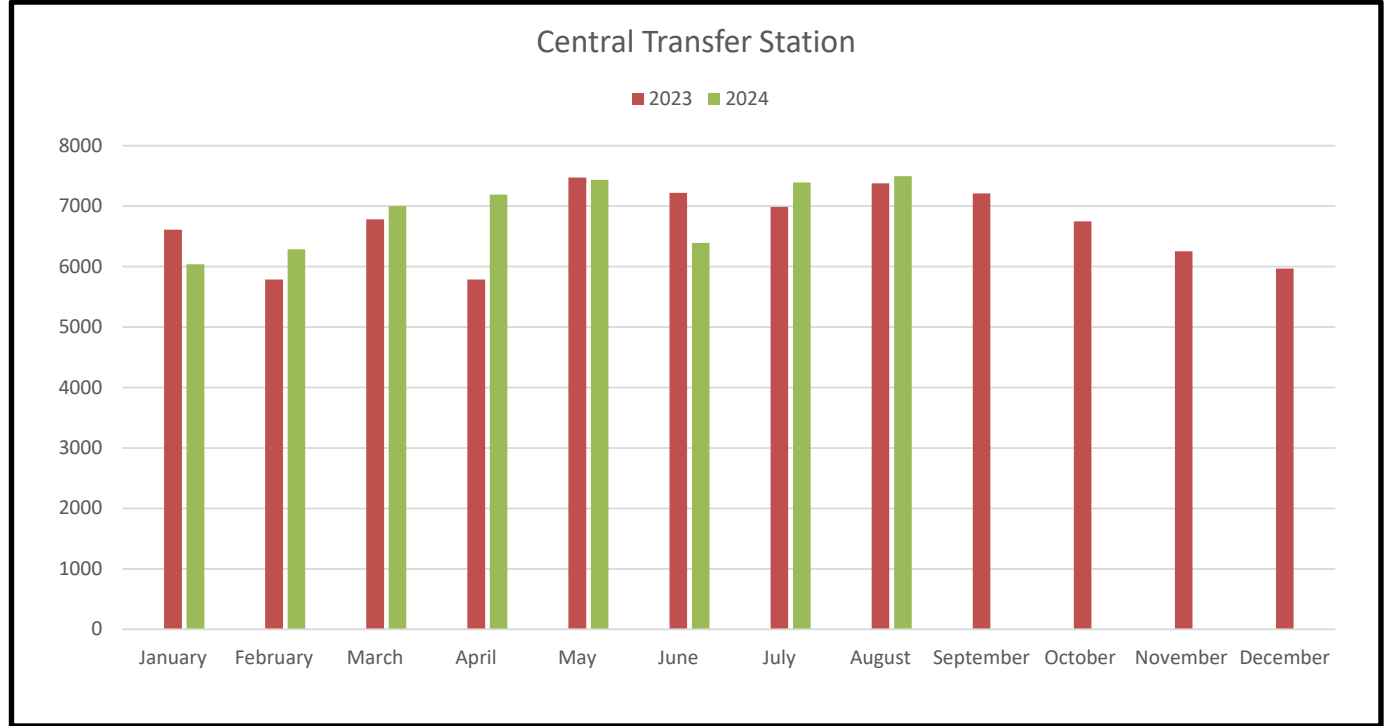
