Corrections Bureau – We currently have eight vacancies in the Corrections Bureau and one Corrections Lieutenant vacancy. Three applicants are in the final stages of the background process, and we hope to have them hired within the next month or so.

Operations Bureau – Sergeant Alan Stull retired effective July 1st after 27 years of service. Deputy Jared Mercer resigned effective July 10th to pursue other career opportunities. One deputy is out on FMLA. The two trainee deputies in the BLEA Burien academy have a little over a month left and are continuing to do well. Sergeant Scott Ferguson was promoted to Patrol Sergeant effective July 2nd. Deputy Skylar Eastman will be promoted to Patrol Sergeant effective July 16th. Deputy Darrell Tevis was selected to fill the vacant detective position. Two entry and one lateral deputy applicants are in the background process. Our new K-9 Kimbo was selected to receive a bullet and stab protective vest thanks to the non-profit organization Vested Interest in K9's, Inc.

Services Bureau – Our Support Technician 1 on probationary employment is progressing well in her FTO training.
