NOTICE IS HEREBY GIVEN that Lewis County has received a Type III - Subdivision Formal Long Plat application packet and SEPA Checklist from Merrlawski Investment LLC (Chris Merritt) for the following development proposal:

Project Proposal: To create a nine (9) lot subdivision (Long Plat) named "Riverside" to include the construction of approximately 800 linear feet of new gated private road with stormwater facilities and emergency vehicle turnaround serving the proposed lots. All nine lots are proposed to be served by water connections from a new Group B Public Water System and will have individual septic systems. The parcel is 12.80 acres in size. Road construction will include approximately 1,900 cubic yards of grading.

Project Location: The project is located at 107 Riverside Drive in Packwood, WA on tax parcel number 035067002003.

Environmental Determination: The proposed project has been reviewed for probable adverse impacts and Lewis County issued a Determination of Nonsignificance (DNS) pursuant to WAC 197-11-340(2) (see attached DNS).
