2. Call to Order

A. Determination of a Quorum

7 Commissioners were present; there was a quorum.

3. Approval of Agenda

The Chair entertained a motion to approve the agenda for November 12, 2024. Commissioner Russell made the motion to approve the agenda; seconded by Commissioner Moore. The motion carried unanimously.

The Chair entertained a motion to approve the meeting notes from October 8 and 22, 2024. Commissioner Moore made a motion to approve the notes as presented, second by Commissioner Alves. The motion carried unanimously.

5. Public Comment

There was no public comment.	

6. Public Hearing: Permitting Timeframes of SB5290

A. Staff Presentation: Mindy Brooks, Lewis County Director of Community Development, shared a presentation on the permit timeframes for SB5290.

Commissioner Skutley asked how Lewis County compares to other counties in terms of the timeframes and deadlines. Mindy Brooks, Lewis County Community Development Director, stated these deadlines come from the RCWs therefore all counties should be the same. Lewis County is typically within the timeframes.

Commissioner Alves asked if someone is building something in a UGA, which jurisdictions do these timelines affect. Mindy Brooks stated that she has been in contact with Centralia and Chehalis as there are current ILA agreements with both cities. The ILAs need to be updated to address the timeframes. In the meantime, Mindy Brooks suggests that if a developer wants to permit a project in the UGA they request an extension to the timeframes to ensure the processes can be completed. The code was changed to state the applicant can request an extension of any time frame instead of the previously stated 90-day extension.

Commissioner Alves asked if Al is a part of the conversation in relations to plan reviews. Mindy Brooks stated that is not a topic of conversation aet this time. The new software will streamline much of the process.

Commissioner Moore asked how the refunds will work and if it affects General Fund. Mindy Brooks stated this process won't affect General Fund because the refunds come from the fees collected.

Commissioner Skutley asked what the commission is voting on. Mindy Brooks stated the commission needs to vote on the code amendments. The commission was provided the code amendments via the staff report prior to this meeting and prior to the October 8th meeting.

Commissioner Russell stated the permit center does not allow applications to be turned in without

all the requirements. He also stated he has no reservations about this subject.
