1. Zoom Guidelines

The clerk dispensed with the Zoom Guidelines.

2. Call to Order

A. Determination of a Quorum

7 Commissioners were present; there was a quorum.

3. Approval of Agenda

The Chair entertained a motion to approve the agenda as presented. Commissioner Russell made the motion to approve the agenda as presented; second by Commissioner Spogen. The motion carried unanimously.

4. Approval of Meeting Notes

The Chair entertained a motion to approve the meeting notes from July 23, 2024. Commissioner Russell made a motion to approve the notes as presented, second by Commissioner Skutley. The motion carried unanimously.

5. Public Comment

There were no members of the public who wished to provide public comment.

6. Workshop - Comprehensive Plan Periodic Update - Climate

Mindy Brooks, Director of Community Development, gave a presentation on the Comprehensive Plan Periodic Update (*see presentation for details*). Throughout the presentation the commissioners asked the following questions.

Commissioner Russell asked what decisions the Planning Commission made around Urban Growth Area (UGA) expansions for Chehalis. Mindy responded that in 2022 UGA expansions were requested by individual property owners, as this was the past practice. Some of these requests were approved. However, moving forward, staff has urged the cities strongly to not expand UGAs based on individual property owners, as the law looks at whether a city can accommodate growth and if they cannot, then they should look at UGA expansion. In 2023 the cities began their land capacity analysis.

Commissioner Skutley asked if 8,000 units is the correct number based on 2.5 people per dwelling unit. Mindy responded that the cities used their average persons per household number for their Land Capacity Analysis. Skutley asked if the analysis takes into consider the number of sales. Mindy responded that the analysis is simply how many people could the UGA accommodate based on current zoning over the next 20 years, which does not include the sales of houses. We assume that over 20 years, all housing that can be occupied will be.

Commissioner Russell thanked the City of Chehalis, their new city manager, and Lewis County staff for fixing this number. The takeaway is that when multiple people tell you that something isn't right, it's important to listen. As the city is resetting and reengaging, they should listen to people who've got ideas about where to go to stay out of critical areas. This is a good time to think about the future and it gives me hope. Commissioner Alves expressed agreement with Russell.

Mindy concluded this topic with next steps including going to Planned Growth Committee in August, holding a hearing with Planning Commission in September, and holding a hearing with the BOCC in November.

7. Good of the Order:
