NOTICE IS HEREBY GIVEN that the LEWIS COUNTY HEARING EXAMINER will hold a virtual land use public hearing on Friday, January 10, 2025, starting at 9:00 a.m., or shortly thereafter, for the purpose of taking public testimony and rendering a decision concerning a shoreline variance request (SHD24-0002). This hearing will be by remote virtual hearing only and no in-person public access to the hearing room. This is the only item on the agenda docket.

Project: SHD24-0002 - The applicant has requested a variance to reduce the 150-foot shoreline buffer of Big Creek to construct a single-family residence with associated utilities and new gravel driveway. The variance request is to reduce the 150-foot shoreline buffer to 36 feet for the residence and 81 feet for the septic drainfield. A No Net Loss of Ecological Function Report and Mitigation Plan has been prepared for the reduced setback from Big Creek.

The project is located at 110 Mountain View Dr N, Ashford, Lewis County, WA – Section 36, Township 15N, Range 06E, WM. Shoreline application file number SHD24-0002.
