RE: January 28, 2025, Planning Commission briefing – 2045 Comprehensive Plan Periodic Update – Existing Conditions

The Lewis County Comprehensive Plan is a 20-year plan. It sets the policy direction for future growth (jobs/economic development, housing, population), protection of critical areas and both rural and resource (agricultural, forest, and mineral) lands, and planning transportation, capital facilities, and utilities needed to support growth.

The comprehensive plan is updated every 10 years. The update process is referred to as a periodic comprehensive plan update. This update extends the planning horizon out to 2045. The primary goals of the periodic update to:

- Engage the community and update policies consistent with the local vision for growth
- Plan for housing, population, and employment out to 2045
- Update policies and regulations consistent with state law changes/case law since the last periodic comprehensive plan update
- Update critical area regulations consistent with new Best Available Science (BAS)

The updated comprehensive plan must be consistent with state law and regional policies, which are shared between the county and cities within the county. These are called Countywide Planning Policies (CPPs). Adopted policies in the comprehensive plan are implemented in a number of different ways. For example, it can occur through development regulations, coordination with partner organizations to meet regional goals, or through the capital facility planning, just to name a few.

As part of the 2025-2045 periodic comprehensive plan update, we are developing an implementation chapter. This chapter will help ensure that the future goals of the county, expressed through policy, have an implementation mechanism. This should also assist the community, planning commission, and Board of County Commissioners understand will happen after the Plan is adopted.

The Kimley-Horn team is excited to lead this briefing on January 28th as part of a series of briefings to present the updates to Lewis County's Comprehensive Plan.

Meeting Materials and Preparation

In preparation for the meeting, it is recommended that the Planning Commission review the existing Comprehensive Plan on the website and the policy changes summary boards presented at the open house in October 2024.

Starting in May, the Board of County Commissioners will hold public meetings and hearings following a similar schedule to the Planning Commission meetings schedule between January and July. All elements of the Periodic Update – goals, policies, maps, zoning and development regulations – are anticipated to be adopted by the BOCC by September 2025.

PROJECT BACKGROUND

The Washington State Growth Management Act (GMA) requires Lewis County to update its Comprehensive Plans and implementing development regulations every 10 years (RCW 36.70A.130). Comprehensive Plans are 20-year policy documents that guide and plan for growth (population and employment), housing, transportation, capital facilities and utilities, parks, recreation and open space, rural areas, and protection of natural resource lands (RCW 36.70A.070). Lewis County is required to complete the periodic comprehensive plan update by December 30, 2025¹. Comprehensive Plan updates are an opportunity to revise the existing Plan to ensure consistency with state



laws/case law since the last update and Best Available Science (BAS) for incorporation into critical areas regulations. This update also provides a great opportunity to balance state requirements with community vision to shape the future for Lewis County.

The following is a summary of the events held to date.

The primary themes that have emerged from the public engagement are:

- 1. **Maintain rural character.** This means containing high density growth, preserving farms, forests and small towns and protecting open spaces and the environment.
- 2. Encourage jobs. This means supporting local, family-owned businesses in rural areas and small towns and encouraging larger-scale development near Interstate 5 and other state highways.
- 3. **Provide housing options.** This means creating opportunities for different types of housing and reducing the cost-burden on existing homeowners.
- 4. **Improve public safety.** This means ensuring adequate police, fire and EMS services and providing appropriate transportation and communication infrastructure to support expected growth.
- 5. **Address natural hazards.** This means reducing the risk to people, property and infrastructure from extreme weather events such as flooding and wildfire.

These themes are infused throughout the goals, policies and maps that will be presented to the Planning Commission over the next three meetings. It is our goal to help the community see where their vision for the future is addressed in the Lewis County 2045 Comprehensive Plan.
