

Recap of PC and BOCC Priorities

PC and BOCC Priorities

Land Use – Continue exploring how land use can bolster economic development and funding for infrastructure. Improving planning and permitting.

Rural Areas – Clearly establish rural character and rural land use designations.

Housing – Short-term rentals and funding mechanisms to support housing programs and infrastructure.

Transportation – Public transit expansion; continued focus on infrastructure improvements.

Capital Facilities & Utilities – Prioritize funding for communication systems.

Resource Lands - Emphasis on conservation.





PC and BOCC Priorities Continued

Economic Development – Explore ways to decrease light and other pollution with increase in tourism. Transition to green industries/green jobs. I-5 Corridor improvements. Expansion of energy industries.

Climate & Resiliency – Clearly communicate and educate on critical areas and floodplains. Increase mitigation and planning for fire mitigation.



Hazard Mitigation Plan (HMP) and Climate & Resiliency



Climate & Resiliency Element

The Climate & Resiliency Element must establish specific goals, policies, and programs designed to:

- Identify, protect, and enhance natural areas to foster resiliency to climate impacts;
- Identify, protect, and enhance community resiliency to climate impacts; and
- Address natural hazards created or aggravated by climate, including sea level rise, landslides, flooding, drought, heat, smoke, wildfire, and other effects of changes to temperature and precipitation patterns.



Hazard Mitigation Plan Summary

Identify risks from hazards (should they occur) and prioritize strategies to reduce impacts.

- Address the Disaster Mitigation Act (DMA)
- Coordinate with partners to address hazards
- Create a risk assessment of County hazards
- Identify roles of partners between planning, funding, and mitigation
- Coordinate plans and programs to mitigate possible disaster impacts

Policy Revision Methodology

- Goals are a broad, long-term vision or desired outcome that a community, organization, or government wants to achieve.
- Policies are specific guidelines or principles that provide direction on how to achieve the overarching goals outlined in the plan, sometimes these are listed as actions.

Example:

Goal: Promote compact development patterns to preserve natural resources, reduce urban sprawl, and enhance community livability.

Policy: Allow compact developments and conservation subdivisions in rural areas.



Policy Revision Methodology

- Growth Management Act (GMA) Recommendations to align policies with recent state legislative changes.
- <u>Regional/Countywide Planning Policies (CPPs)</u> Recommendations to align with policies with CPPs.
- <u>Community Vision</u> Recommendations based on community feedback collected through engagement.
- <u>County Vision</u> Recommendations to align policies with vision of BOCC, PC, Staff, and adopted County plans.
- <u>Administrative Cleanup</u> Recommendations to make the policies clear, concise, and actionable. Clearly identify what is being implemented.


Climate & Resiliency Element Goals and Policies Summaries (7 Total)

- **CR 1.0 Prepare buildings against potential hazards.** Fire resilience, utility improvements for subdivisions, improve existing utility infrastructure to buildings.
- CR 2.0 Preserve historic and cultural resources against hazards. Provide education and outreach, protect significant historic sites.
- CR 3.0 Enhance emergency preparedness. Map infrastructure vulnerable to hazards, provide education, outreach, signage, and establish communication systems.
- **CR 4.0 Evacuation systems**. Assess vulnerability, bolster infrastructure, seek funding for new projects.



Climate & Resiliency Element Goals (7 Total)

- **CR 5.0 Public health and wellbeing.** Prioritize hazard mitigation on vulnerable populations; work with property owners, schools, other groups, to protect from hazards.
- **CR 6.0 Governance.** Work on improving County staffing, funding, permitting, regulations, etc. to support this new element.
- **CR 7.0 Funding.** Work on building new sources of funding and exploring grants to support the new element and associated actions.



Revised Transportation Goals and Policies Summaries

- **T 2.0 Resilient.** Improve transportation system that minimizes impacts from flood, wildfire, and other natural hazards.
- **T 8.0 Airports.** Preserve existing airport infrastructure and its benefit to emergency services.
- **T 10.0 Rail.** Preserve and improve existing rail routes that minimize vulnerability and risk from hazards.
- T 11.0 Multi-Modal Transportation. Expand multi-modal options in limited areas of more intensive rural development (LAMIRDs) and UGAs.



- CF 5.0 Energy and Sustainability. Transitioning County facilities to energy efficient or electric. Retrofitting buildings, exploring ways to implement electric vehicles.
- **CF 7.0 County Buildings.** Continue efficiently using existing County buildings and focus County resources geographically.
- **CF 17.0 Broadband.** Strengthen coordination and funding allocation for continued broadband expansion.
- **CF 18.0 Fire Districts.** Continued coordination, data sharing and support between the fire districts and the County.



Implementation Example

Goal CR 1.0 Ensure that buildings and utilities are designed and built sustainably to reduce environmental impacts and remain resilient to extreme weather and other hazards.

Policy CR 1.2 Adopt fire-resilience standards for new and redeveloped sites in high-risk wildfire areas.

Policy CR 1.3 Design existing buildings for passive survivability to ensure that they will stay at a safe temperature for occupants if the power goes out.





Continued Public Participation


Continuous public participation is required for updating the Comprehensive Plan. (RCW 3670A.140, WAC 365-196-600)

- Climate related engagement




2023-2024 Project / Engagement Timeline




