

- <u>County Vision</u> Recommendations to align policies with vision of BOCC, PC, Staff, and adopted County plans.
- <u>Administrative Cleanup</u> Recommendations to make the policies clear, concise, and actionable. Clearly identify what is being implemented.





### **Urban Growth Areas (Changes)**

- UGA 1, 2, 3 Urban Growth Areas Services/Administration. Establish clear policies for boundary changes and administration of Urban Growth Areas, urban reserve, and address GMA.
- UGA 4, 5, 6, 7 Small Towns. Expanding housing, transportation, and services in Lewis County's UGAs (Onalaska & Packwood).
- UGA 8 Master Planned Resorts. Continue expanding opportunities for master planned resorts, address GMA.
- **UGA 9. Major Industrial Developments.** Continue expanding opportunities for master planned resorts, address GMA.

### Rural (Changes)

- RL 4 Type 1 LAMIRDs. Encourage development, housing, and economic opportunities, provide rural services, and preserve history and character.
- RL 5 Type 3 LAMIRDs. Promote small scale industrial and commercial and support the rural economy, no residential in these areas.
- RL 6 Rural Development. Maintaining 5 acres or greater, allowing a variety of housing and clustered developments.
- RL 7 Type 2 LAMIRDs. Promote small scale recreation and tourism, ecotourism, and recreation, limit residential uses.
- RL 8 Open Space. Allowing for parks and open space zoning for preservation.

- **H 4 Preservation and Improve.** Added stronger language to address STRs.
- H 5 Housing Equality. Start reviewing and selecting future housing opportunities to address natural hazard mitigation, reach low-income populations, reach potentially displaced populations, improve health and environment justice.

- NE 4 Water Quality. Protect aquifers from natural hazards.
