DELIBERATION ITEM

Commissioner Pollock made a motion to approve Resolution 25-191. Commissioner Swope seconded.

Resolution 25-191: Ratify Amendment A to contract 25-92601-029 with the Washington State Department of Commerce for LED lighting upgrades at the Lewis County Jail.

County Manager Ryan Barrett discussed the resolution. Ryan said the amendment extends the timeline for the LED project.

Motion passed 3-0.

DELIBERATION ITEM

Commissioner Pollock made a motion to approve Resolution 25-158. Commissioner Swope seconded.

Resolution 25-158: Declare Lewis County a non-sanctuary county and affirm the rule of law.

Commissioner Pollock discussed the proposed resolution. She noted that she has not received a response from Homeland Security Secretary Kristi Noem's office as to why Lewis County was mistakenly listed as a sanctuary county. She noted that the attached exhibit for Resolution 25-158 outlines that the resolution affirms that the county will remain compliant with all state and federal laws.

Commissioner Brummer reiterated that the resolution does not change the due process of law or negate the judicial process.

Commissioner Swope noted that the resolution was drafted in response to the risk of losing public health funding due to the county's presence on Homeland Security's list of sanctuary jurisdictions.

Motion passed 3-0.
